The 20 motion was properly served upon Complainant, who has not filed an opposition to the motion. 21 The motion asserts that the complaint lacks probable cause because it does not allege that 22 the County violated any provision of NRS Chapter 288. The Board agrees. 23 In order to proceed, a complaint must allege a violation of NRS Chapter 288. Although 24 other remedies may exist in different venues, a mere breach of a collective bargaining agreement, 25 without more, is not a violation of NRS Chapter 288. Clark County Classroom Teachers Ass'n v. 26 Clark County School Dist., EMRB Case No. A1-045280, Item No. 44 (1975). The complaint 27

also refers to the Family Medical Leave Act (FMLA), however this Board does not have

jurisdiction over matters arising under FMLA.
