On the 13th day of December, 2011, this matter came on before the State of Nevada, 14 15 Local Government Employee-Management Relations Board ("Board"), for consideration and decision pursuant to the provisions of the NRS and NAC chapters 288, NRS chapter 233B, and 16 17 was properly noticed pursuant to Nevada's open meeting laws. 18 Complainant Tal Harel has filed a Petition for Rehearing following the Board's order 19 dismissing his complaint by construing the lack of an opposition to Clark County's motion to 20 dismiss as consent to granting the motion under NAC 288.240(6). Harel did in fact file an opposition to the motion, however the opposition was not received by the Board until after the 21 22 Board had pronounced its order dismissing the case. Harel acknowledges that the opposition was 23 late, but that the Board should still consider the opposition to the motion under the provisions of 24 NAC 288.235. 25 Having reviewed Harel's petition, we grant the petition for rehearing on the issue of 26 whether the Board should consider Harel's opposition to the County's motion to dismiss 27 pursuant to NAC 288.235. 28 111

Pursuant to NAC 288.362, Clark County may file a response to Harel's petition within 15 days of the date of this order.

Pursuant to NAC 288.364(4), this matter will be placed upon the agenda for a future board meeting, so that the Board may consider the petition and any response filed by Clark County and render a timely decision.

Pursuant to NAC 288.366, the effectiveness of the Board's prior order in this matter is hereby suspended until such time as the Board issues a final decision on rehearing pursuant to NAC 288.364(4).
