



**ORDER ON RESPONDENT'S MOTION

**ITEM NO. 842A**

On September 17, 2019, this matter came before the State of Nevada, Government Employee-  
Management Relations Board ("Board") for consideration and decision pursuant to the provisions of the  
Government-Management Relations Act (the "Act"); NAC Chapter 288 and NRS Chapter 233B.

At issue was Respondent University Medical Center of Southern Nevada's ("UMC") Motion to  
Dismiss the First Amended Complaint. Complainant filed a notice of non-opposition regarding the  
certain grievances and provided a stipulation to file a second amended complaint removing those  
grievances.
