13	On September 19, 2024, this matter came before the State of Nevada, Government Employee-			
14	Management Relations Board (Board) for consideration and decision pursuant to the provisions of the			
15	Employee-Management Relations Act (NRS Chapter 288, EMRA) and NAC 288. At issue was			
16	certification of the results of the recently held election.			
17	History			
18	On June 6, 2024, Petitioner AFSCME, Local 4041 filed an Application for Election. After a			
19	review of the record, including the staff audit of the request, the Board deliberated on July 10, 2024,		d deliberated on July 10, 2024,	
20	and decided to grant the request for an election and recommend an election be held pursuant to NRS			
21	288.525(2). The Board issued an order that same day which included the Election Plan as an			
22	attachment to that order.			
23	The election closed on August 26, 2024, and a counting of the ballots was completed on August			
24	27, 2024. A copy of the Tally of Ballots is attached hereto. Section 5.01 of the Election Plan allowed			
25	any party to file objections as to the conduct of the election by December 23, 2022. None were filed.			
26	NRS 288.530(4) states the standard for determining the outcome of an election, which reads as			
27	follows:

1 2	4. If a labor organization receives a majority of the votes cast at the initial election or at any runoff election, the Board shall designate the labor organization as the exclusive representative of the bargaining unit.		
3	Thus, according to the standard used for determining the outcome of the election, it is		
4	determined Petitioner AFSCME, Local 4041 received a majority of the votes cast and thus is designated		
5	as the exclusive representative of the bargaining unit.		
6	ORDER		
7	Based on the foregoing, it is hereby DECLARED and ORDERED that Petitioner AFSCME,		
8	Local 4041 is hereby designated as the exclusive representative of State of Nevada Bargaining Unit C		
9	(i.e., Technical Employees) effective immediately.
