ARBITRATION AND MEDIATION FEE AND EXPENSES

Rate:

Per diem fee in the amount of \$1,600.00 is charged for each day of hearing, for research and preparation of the opinion and award. A hearing day is any portion of a day up to eight hours. Time for research and preparation is prorated.

Travel:

If two or more hours are used for travel, all travel time is prorated at the applicable per diem fee. Charges are made for all actual expenses incurred. Automobile mileage is charged at the applicable IRS expense rate.

Cancellation Fee:

A one-day per diem fee is charged for postponement or cancellation of hearing dates unless notice of twenty-one or more calendar days is given.
