The Executive Director oversees five exempt employees, approximately 1500 attorney case evaluators, and 250 mediators. Administrative responsibilities include fiscal management, overseeing the agency's investments, assets, tax reporting requirements, accounts payable and receivables; human resources; program design and implementation; communication with the judiciary; and interagency coordination with other legal agencies and overseers.
