ARBITRATION AND MEDIATION EXPERIENCE:

I have been selected as an arbitrator in more than 2000 cases in the public, private and federal sectors since 1981, and have functioned as an arbitrator full time since 1987. I have addressed such issues as seniority, layoff, recall, bumping, unit coverage, work performance, leaves of absence, holiday and vacation eligibility and pay, overtime eligibility and pay, shift hours, promotion, transfer, alcohol and drug use, health insurance, retirement, arbitrability, management rights, past practice, contracting out, discipline and discharge.
