Upon motion, the Board denied Respondents' Motion to Dismiss First Amended Prohibited Practices Complaint and thereupon also granted a hearing in the case. Based on input from the parties, it was agreed that staff would hold a separate WebEx conference to randomly select the hearing panel.
8. **Case 2020-002**
AFSCME, Local 4041 v. State of Nevada, Department of Corrections, High Desert State Prison; Brian E. Williams, Sr., Warden
Upon motion, the Board denied Respondents' Motion to Dismiss First Amended Prohibited Practices Complaint and thereupon also granted a hearing in the case. Based on input from the parties, it was agreed that staff would hold a separate WebEx conference to randomly select the hearing panel.
9. **Case 2018-006**
Charles Ebarb v. Clark County & Clark County Water Reclamation District
