In re: Petition for Designation as the Exclusive Representative of a Bargaining Unit Pursuant to NRS 288.520

Chair Eckersley opened the floor for any public comment on this item. Thereupon, Thomas Donaldson, Esq., who represents the Battle Born Firefighters Association, gave an overview of the petition and the numbers that purport to represent, which is 56.4% of the bargaining unit.

Tom Dunn, of the Battle Born Firefighters Association, introduced himself and stated he was available for any questions. There was no other public comment.

Commissioner Snyder then reiterated what had previously been stated and that the audit report did indeed show that the Battle Born Firefighters Association has evidence it represents more than 50% of the employees in the bargaining unit and thus it was his recommendation that the Board approve the labor organization as the exclusive representative.

The Board then deliberated on the petition, and upon motion, designated the Battle Born Firefighters Association as the exclusive representative for Unit E.
