4. Case 2019-007

Nye County Management Employees Association and Ronni Boskovich, Daniel Young and Patrick Ferguson v. Nye County

Pursuant to NAC 288.271(2)(c), the Commissioner had previously randomly selected Board Member Cottino to replace Board Member Harris, who had recused herself. The attorneys explained that the settlement agreement has been executed by one party and is awaiting execution by the second party. Afterwards, the Respondent then has 30 days to pay out the funds. Upon motion, the Panel ordered that the parties return for another Hearing to Show Cause at the February meeting, unless a stipulation to dismiss is submitted prior to then.


The following 8 items were for consideration by the full Board:

5. Approval of the Minutes

Upon motion, the Board approved as presented the minutes of the meeting held December 16-17, 2020.

6. **Case 2017-012**
City of Las Vegas v. Las Vegas Peace Officers Association
Upon motion, the Board granted the Stipulation and Order for Dismissal With Prejudice, as presented.
7. **Case 2020-022**
International Union of Operating Engineers, Local 501 v. Esmeralda County; Esmeralda County Board of Commissioners; et al.
Upon motion, the Board granted a hearing in the case, with the date of the hearing to be scheduled by the Commissioner. The case was then randomly assigned to hearing Panel A. The Commissioner then advised that the hearing would tentatively be scheduled for March 2-4, 2021.
8. **Case 2020-025**
Nye County Law Enforcement Officers Association v. Nye County
Upon motion, the Board granted a hearing in the case, with the date of the hearing to be scheduled by the Commissioner. The case was then randomly assigned to hearing Panel E. The Commissioner then advised that the hearing would tentatively be scheduled for March 16-18, 2021.
9. **Case 2020-029**
In Re: Petition to Expand Bargaining Unit K Pursuant to NRS 288.515
Upon motion, the Board granted the State of Nevada's Request to File an Amicus Brief, which was noted as being unopposed by the Petitioner. It was also noted that the State of Nevada agreed to allow the Petitioner to file a response to its amicus brief.
10. **Case 2020-012**
Operating Engineers Local #3 v. Incline Village General Improvement District
The Board deliberated on Complainant's Offer of Proof, and upon motion, decided to have both parties appear before the Board on January 28, 2021, to show cause as to whether the stay should be lifted.
11. **Additional Period of Public Comment**
No public comment was offered.

There being no additional business to conduct, Chair Eckersley adjourned the meeting.
