1. Call to Order & Roll Call

The meeting was called to order by Chair Brent C. Eckersley, Esq. at 9:30 a.m. On roll call all Board Members were present, thus constituting a quorum.

The following 1 item was for consideration by Panel C:

4. Case 2022-002

<u>Association of Professional-Technical Administrators v. Washoe County School</u> District

Pursuant to NAC 288.271(2)(c), the Commissioner had randomly selected Vice-Chair Masters to fill the vacancy on the panel. Also pursuant to NAC 288.271(2)(c), the Commissioner had selected Chair Eckersley to fill the vacancy on the panel caused by the resignation of Board Member Harris. Pursuant to NAC 288.271(4) the presiding officer was Chair Eckersley. The hearing on the case was postponed and was not rescheduled at this time.

5. Case 2021-002

Nevada Association of Public Safety Officers v. Las Vegas Metropolitan Police Department and Las Vegas Police Protective Association

The Board deliberated on the Joint Status Report, but took no action at this time, thus keeping the stay in effect. The date for the next report will be due February 28, 2023.

6. Case 2022-008

<u>Las Vegas Police Managers & Supervisors Association & Connell v. Las Vegas</u> Metropolitan Police Department

The Board deliberated on the Joint Status Report, and upon motion, voted to lift the stay and directed the prevailing party to file a motion to defer or such other motion within 21 days of issuance of the order.

7. Case 2022-011

<u>Las Vegas Police Protective Association v. Las Vegas Metropolitan Police</u> Department

The Board deliberated on Respondent LVMPD's Motion to Lift Stay, and upon motion, lifted the stay. Commissioner Snyder stated that this item will come back before the Board at its next meeting to (1) deliberate and decide on a pending petition to intervene by the Las Vegas Police Managers and Supervisors Association and (2) to deliberate on whether to grant a hearing on the case.

8. Case 2022-013

Las Vegas Peace Officers Association v. City of Las Vegas

The Board deliberated on the Petition for Declaratory Order, and upon motion, agreed with the position of the City that it is to offer the deductions on a pre-tax basis and that it is then required by the IRS for affected employees to determine whether they wish to elect the deduction on a pre-tax basis, and if so, then to complete the required IRS form. Board Member Smith voted nay.

9. Case 2022-014

In Re: Category III Peace Officers Bargaining Unit "I" Request for Election by Fraternal Order of Police Nevada C.O. Lodge 21 Pursuant to NRS 288.525(2)(a)(1) The Commissioner presented the Election Plan and associated documents. Upon conclusion of the presentation, representatives for the petitioner, the incumbent labor organization (i.e., AFSCME, Local 4041) and the State of Nevada then addressed the Board. Thereupon the Board approved the Election Plan with the change to Section 2.05 offered by Adam Levine and a change offered by Commissioner Snyder to Section 4.02. Both changes were unopposed by the parties involved in the matter.

After approval of the Election Plan, the Commissioner then supervised a random drawing to determine which labor organization was to get first choice as to placement on the ballot. FOP won the random drawing, thus receiving first choice. Thereupon FOP chose to be placed first on the ballot. AFSCME then chose to be placed second on the ballot, thus making the "No Union" option placed last on the ballot. The parties agreed to use "FOP" and "AFSCME" to delineate the two labor organizations on the ballot.

10. Approval of the Minutes

Upon motion, the Board approved the minutes of the meeting held October 13, 2022 with the correction of a date as found by Board Member Smith.
