The Board deliberated on Respondent's Motion to Dismiss Complaint or Alternatively Defer the Complaint. Upon motion, the Board granted the motion to dismiss without prejudice and denied all other relief.

# 11. Commissioner's Report

First, he went through the Governor's proposed budget for the agency, highlighting budget items that are significantly increased or decreased from the current budget. He also noted that new chairs for the Board are included in the budget.
