# 7. <u>Follow-Up to Report Regarding Assignment of Executive Department Job</u> Classifications to Bargaining Units

The Board deliberated on the Stipulation submitted by the State of Nevada and AFSCME. As the Stipulation was submitted without association to a pending case, the Commissioner requested that it be filed under Case 2019-017, *In re: Assignment of Executive Department Job Classifications to Bargaining Units Pursuant to Senate Bill 135 of the 80th Session of the Nevada Legislature.* Upon motion, the Board ordered that the Stipulation be filed under Case 2019-017 and approved the Stipulation as drafted.

#### 8. Case 2025-011

#### Las Vegas Peace Officers Association v. City of Las Vegas

Upon motion, the Board denied the request to dismiss and granted the request to defer under the limited deferral doctrine. #### Hector Villa v. Henderson Police Officers Association

The Board deliberated on Respondent's Motion to Dismiss. Board Member Snyder disclosed that, more than twenty years ago, he had served as counsel in a case referenced by Respondent in its reply. He further stated that such prior work would not affect his vote in the present matter. Upon motion, the Board denied the Motion to Dismiss. The parties are directed to file their prehearing statements within twenty-one (21) days of the entry of the order on the Motion to Dismiss.
