1. Opening Items

The meeting on Thursday, October 16, 2025, was called to order by Chair Eckersley at 8:30 a.m. On roll call, all members were present. Thus, a quorum was present. The pledge of allegiance was recited, followed by a moment of silence.

4. Approval of the Minutes

Upon motion, the Board approved the minutes for the meeting held September 22-24, 2025.

5. Case 2025-005

Justin Darling v. Las Vegas Valley Water District

The Board reviewed and deliberated on the Joint Status Report but took no action at this time. The parties were advised that the next Joint Status Report is due January 14, 2026, or within ten (10) days following the issuance of the arbitration decision, whichever occurs first.

6. Case 2025-014

Lander County Classroom Teachers Association v. Lander County School District

The Board deliberated on the Respondent's Motion to Dismiss Appeal of Unit Determination. Upon motion, the Board denied the Motion to Dismiss Appeal of Unit Determination.

7. Case 2025-015

Clark County v. Clark County Defenders Union, et al.

Board Member Michael Urban recused himself from deliberation on the Petition for Declaratory Order due to his prior representation of one of the Respondents.

The Commissioner declared the matter to be of statewide significance, allowing the case to be heard before the full Board.

Upon motion, the Board took the following actions: (1) approved allowing oral arguments by the parties pursuant to NAC 288.410; and (2) approved permitting *amicus* briefs to be filed by November 30, 2025, by any local government or employee/labor organization under the Board's jurisdiction. The time for oral arguments was set at one hour for the

Petitioner, including rebuttal, and one hour for the Respondents, to be divided among all Respondents who previously filed responses to the Petition for Declaratory Order. Board Member Urban abstained from voting on the motion.

The Board held further discussion with Allison Kheel, Esq., counsel for Clark County; Adam Levine, Esq., counsel for the Clark County Defenders Union and the Clark County District Attorneys' Investigators Association; and William Schuller, Esq., counsel for the Clark County Law Enforcement Association regarding the date for oral argument. Upon agreement, oral arguments were scheduled for December 15, 2025, at 8:30 a.m.

8. Election of Chair and Vice Chair

Upon motion, the Board elected Brent Eckersley as Chair and Michael Urban as Vice Chair.

9. Setting of Future Board Meeting Date

A proposal was made to schedule the December Board meeting for December 17, 2025, at 8:30 a.m. Upon motion, the Board approved December 17, 2025, as the date for the December meeting.

Later in the meeting, the Chair reopened this item and proposed rescheduling the meeting to December 15, 2025. Upon motion, the Board approved December 15, 2025, at 8:30 a.m. as the date and time for the December meeting.

10. Additional Period of Public Comment

No public comment.

There being no additional business to conduct, Chair Eckersley adjourned the meeting.
