14. Commissioner Job Announcement

Commissioner Snyder stated that job announcement was revised as discussed at the last meeting by adding the section entitled "Selection Process." He further stated that salary listed on page 1 has been increased by 11% as that is the raise that was given as of July 1, 2024 to all employees pursuant to Assembly Bill 522 of the last legislative session. Upon motion, the Board approved the job announcement with one change to list October 9, 2024 as the date set for interviews. Commissioner Snyder then stated that in addition to posting the job announcement on the State's job vacancies website for unclassified jobs and sending the job announcement to everyone on the EMRB's mailing lists, he also has agreements for the Labor and Employment Section of the State Bar of Nevada and two management trade groups to also post the position and send blast e-mails to their members.

15. Case 2024-020

<u>In re: Petition of American Federation of State, County & Municipal Employees, Local 4041</u>

Commissioner Snyder presented the audit report for the request for election filed by AFSCME, Local 4041. The audit report shows that the petitioner has met the requirements of NRS 288.525(1) and specifically that the audit shows support of 33.2%, which exceeds the minimum threshold of 30% for an election to be called.

Commissioner Snyder then went through the provisions of the election plan and associated documents. Upon motion, the Board ordered that an election be held and adopted the election plan and associated documents with the changes agreed to by the parties for Section 2.05 concerning campaigning.

To the Nevada Employee-Management Relations Board:

We the undersigned leadership of the Washoe Professional Technical Association (WPTA) and School Psychologist Association of Washoe (SPAW) would like to ensure that the EMRB is aware that the Association of Professional-Technical Administrators (APTA) no longer represents any Washoe County School District employees. Up until January 2024, APTA represented both the Professional Technical employees and the School Psychologists employed by the Washoe County School District. In January 2024, the Washoe County School District Board of Trustees (WCSD BOT) recognized WPTA as the exclusive bargaining agent of the Professional Technical employees and in June 2024 the WCSD BOT recognized SPAW as the exclusive bargaining agent of the School Psychologists. These withdrawals from APTA were voluntary and were made with the overwhelming support of Professional Technical employees and School Psychologists.

APTA is currently the exclusive bargaining representative for 228 WCSD employees, numbering 183 non-confidential Professional-Technical employees and 45 School Psychologists. The majority of affected employees have voted in favor of leaving APTA to form a separate employee organization to serve as the exclusive bargaining representative for the Professional-Technical employees.

NAC 288.145 - Withdrawal of recognition of organization by local government employer

- **1.** In addition to the reasons set forth in subsection 3 of NRS 288.160, a local government employer may withdraw recognition of an employee organization if the employee organization:
- (a) Voluntarily withdraws in writing as the bargaining representative; or
- **(b)** Fails to notify the employer pursuant to NRS 288.180 that it desires to negotiate.
- **2.** Except as otherwise provided in NAC 288.146, a local government employer must request a hearing before the Board and receive the written permission of the Board before withdrawing recognition of an employee organization for any reason other than voluntary withdrawal.
