1 This case was stayed by the Board on November 5, 2021. The Association has filed two
2 complaints for declaratory relief in District Court.

3 In case no. A-21-835584-C, the Court is asked to decide whether the collective bargaining
4 agreement requires the City to pay longevity benefits to officers.
5

6 A related case has been filed in case no. A-21-845029-C, which asks the court to determine
7 whether the collective bargaining agreement allows the City to refuse to arbitrate longevity benefit
8 claims when the City believes the grievances are untimely. The case was consolidated with A-21-
9 835584-C.

11 The City filed a Motion for Summary Judgment on June 17, 2024. On December 19, 2024,
12 Judge Israel issued an Order granting the City's Motion for Summary Judgment as to both cases
13 and entered judgment on behalf of the City. The Association filed a Notice of Appeal on January
14 17, 2025.

15 This matter is now on appeal. The complainants opening brief and appendix is presently
16 due June 16, 2025.
