4. Case 2024-019

Clark County Prosecutors Association v. Clark County

The Board deliberated on Respondent's Motion to Consolidate or Stay and, upon motion, agreed to stay the case pending completion of Case 2024-016.

5. Case 2024-016

In the Matter of the Clark County's Petition for Declaratory Order

The Board deliberated on the Petition for Declaratory Order, and upon motion, came to the following decision: (1) to grant a hearing pursuant to NAC 288.410 and (2) to allow the filing of amicus briefs by December 31, 2024 on the issues presented in the petition. Commissioner Snyder stated that he would be issuing a declaration that this was a case of statewide significance, thus keeping the hearing before the full Board instead of it being assigned to a panel. Prehearing statements will be due 21 days upon the notice of entry of the order. The case will then come back before the Board after the filing of the prehearing statements to select a hearing date(s). Board member Urban did not participate in the deliberations and abstained on the vote.

6. Case 2024-022

Shelia Leijon v. Incline Village General Improvement District

The Board deliberated on Respondent's Motion to Dismiss, and upon motion, came to the following decision: (1) to grant the motion with respect to the NRS Chapter 281 issue; (2) to deny the motion with respect to the NRS 288.280 issue in that the complaint did address NRS 288.270; and (3) to grant a hearing, to be bifurcated, with the first part of the hearing being limited to the issue of unequivocal notice. Prehearing statements will be due 21 days upon the notice of entry of the order. The case will then come back before the Board after the filing of the prehearing statements to randomly assign the case to a hearing panel and to select a hearing date for the first part of the bifurcated hearing.

7. Case 2024-024

Nevada Service Employees Union v. Clark County

The Board deliberated on the Motion to Partially Dismiss, and upon motion, granted the motion to dismiss those claims not part of the original complaint that was allowed to be refiled. Prehearing statements will be due 21 days upon the notice of entry of the order. The case will then come back before the Board after the filing of the prehearing statements to randomly assign the case to a hearing panel and to select a hearing

The case will then come back before the Board after the filing of the prehearing statements to randomly assign the case to a hearing panel and to select a hearing date(s). Board member Urban did not participate in the deliberations and abstained on the vote.
