MEMORANDUM OF POINTS AND AUTHORITIES

1. NAC 288.278 provides that representation before the Board in a contested case, such as the instant claim, is limited to attorneys licensed to practice in Nevada. NAC 288.278(1).
2. However, the rule also provides that a party may move to waive the limitation to allow an attorney licensed outside of Nevada to “associate with an attorney who is licensed to practice law in the State of Nevada.” *Id.*
3. City Attorney Kristina Gilmore is licensed to practice law in the State of Nevada.
4. The City seeks to have additional representation from Kelly Coyle of Clark Baird Smith LLP an attorney licensed to practice in the State of Illinois (ARDC No. 6312591).
5. The City, by extension, moves this Board to allow Attorney Coyle to associate with Attorney Gilmore so that Attorney Coyle may represent the City’s interests in the above-captioned matter.
6. This is the first instance in which Attorney Coyle would associate with a Nevada attorney for representation purposes.

WHEREFORE, the City respectfully requests that pursuant to NAC 288.278 the Board grant its Motion to waive the limitation on representation and allow Attorney Kelly Coyle to
