23 “CLV”), by and through its attorney of record, Nechole Garcia, Esq. hereby submit their Joint
24 Status Report pursuant to the Commissioner’s email dated July 19, 2023 in the above referenced
25 matter.

1 This case was stayed by the Board on November 5, 2021. The Association has filed two
2 complaints for declaratory relief in District Court.

3 In case no. A-21-835584-C, the Court is asked to decide whether the collective bargaining
4 agreement requires the City to pay longevity benefits to officers.

5 A related case has been filed in case no. A-21-845029-C, which asks the court to determine
6 whether the collective bargaining agreement allows the City to refuse to arbitrate longevity benefit
7 claims when the City believes the grievances are untimely. The case was consolidated with A-21-
8 835584-C.
9

10 The City filed a Motion for Summary Judgment on June 17, 2024. On December 19, 2024,
11 Judge Israel issued an Order granting the City's Motion for Summary Judgment as to both cases
12 and entered judgment on behalf of the City. The Association filed a Notice of Appeal on January
13 17, 2025.

15 This matter is now on appeal. A docketing statement was filed and the parties are awaiting
16 the issuance of briefing deadlines.
